A deposit of 50% [**\$150.00 non-refundable**] is payable two weeks before the event date. The balance is due before the finished product is delivered, or product will not be released. If less than two weeks before event, full payment must be made.

In the event that more than one client wishes to book event services on the same day, preference will go to the **first** client to pay the deposit. Rescheduled event will only be accommodated if the new date does not conflict with another booked client.

Taylor Studios will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or obstruct the professional coverage.

It is the client's responsibility to secure access to areas for videography. *Taylor Studios* will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of *Taylor Studios*.

Taylor Studios will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, tape glitches, etc.

Taylor Studios reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full.

Any liability on the part of *Taylor Studios* will be limited to the amount of monies paid by client.

Upon taking possession of the finished product, the client must inform *Taylor Studios* of any technical or other problems with the video within 7 days. After 7 days, if no notification has been received, the client will be deemed to be satisfied with the product.
