- 6. **CLIENT** shall approve the written production budget submitted in advance by the **PRODUCER**.**PRODUCER** warrants that the production shall cost no more than the grand total listed on said budget without prior written consent of the **CLIENT**. **CLIENT** reserves the right to increase, not decrease said budget at any time after budget approval.
- 7. **PRODUCER** shall submit production schedule to the **CLIENT** for approval. Once said production schedule is approved in writing, any deviation or delay there from
